The Dickson Gallery of Fine Art and Carolina Avenue Salon proudly announce "The Gallery of Hair Juried Art Show".

ELIGIBILITY & MEDIA

Participation is open to anyone interested in contributing their artistic talents to this unique art show. All work represented must be of an original concept executed and designed by the artist. The content of the work MUST be a depiction of something hair related (i.e., curlers, hairdryers, wigs, scissors, combs, portraits of people focusing on their hair, etc)

All media is eligible for this show (Pen & Ink, Oil, Acrylic, Watercolor, Pencil, Colored Pencil, Charcoal, Mixed Media, Collage, Pastel, Metal, Wood, Hand-made paper, Photography, Ceramic, etc.) but must be wall mountable.

All art entries are to be delivered to the Dickson Gallery of Fine Art, 118 E. Lafayette St. Downtown Jackson during the dates specified below. The top 30 pieces will be selected and transported to Carolina Avenue Salon, 365 N Parkway, Suite 100, Jackson. Only selected works will then be displayed as a juried show from May 3 to May 31. (See below for date and time of spotlight reception).

Criteria for selection will be based on originality, use of hair theme, expression and quality of workmanship.

All artwork not selected for the show, artists will be notified by email and/or phone. All artwork not selected for the show must be picked up from the Dickson Gallery of Fine Art, 118 E. Lafayette St, Downtown Jackson within 3 days of notification. Any artwork not arranged for pick-up within 3 days will become property of Carolina Avenue Salon.

SPECIFICATIONS

Size Limit- no smaller than 8"x10" & no larger than 24"x36". All work must be appropriately wired for hanging with eye-hooks, strap hangers or saw-tooth hangers. Works not finished properly for wall-hanging will not be accepted. Please be aware that the quality and condition of your finished work may effect judges' final decision. Please attach to the back of your pieces the following information: Title, Medium, Size, Price, Artist's Name, Artist's Contact Information. Students please also list the school you're attending and your grade. (Also note that the first prize winner's artwork will be purchased for the prize money awarded of \$500)

ENTRY FEE

Entry fee: \$20 per entry. (adults 18 or over)

Entry fee: \$10 per entry. (students under 18)

No refunds will be made for cancellations. Please make checks payable to The Dickson Gallery of Fine Art.

SALES

Works will be for sale during the May 3-31 show at Carolina Avenue.

Sale price should include a 20% commission (to help offset show administrative costs). ALL WORKS submitted MUST be for sale. Works will be sold at the price listed on the entry form. Works may not be removed before the end of the show for any reason.

All Artists are requested to attend the Spotlight Reception at Carolina Avenue Salon, 365 N Parkway, Suite 100, Jackson celebrating "The Gallery of Hair Juried Art Show" on Thursday, May 3rd from 6:00p-9:00p.

AWARDS

1st Place- \$500.00 (this is a purchase award in that Carolina Avenue Salon will be purchasing this piece).

2nd Place- \$200.00

3rd Place- \$100.00

Winners will be notified by phone.

5/3-31/07: Top 30 artworks on display at Carolina Avenue Salon.

5/31/07: Last day of show at Carolina Avenue Salon.

6/1/07: Pick up artwork* at Carolina Avenue Salon 11am-5:00pm. *All other artwork must be removed from Carolina Avenue Salon by 5:30pm June 1st. *Artist may be required to show proper ID prior to return of their artwork.*
